#### 3. Description of the processing operation

##### 3.1. Area of activity in which the processing is carried out

To raise awareness among the youth about sustainability and the upcoming UN conference in Rio de Janeiro, the EEA decided to organise a video competition 'Generation '92 – Share your vision of a sustainable future'. Twenty submissions will be short-listed and will take part in an online vote to determine the public prize winner. Only the name of the video and a short description will be displayed.

This will be an online competition and three participants will receive cash prizes and one video will receive the public prize. All four winners will be able to travel to Copenhagen to take part in an event/award ceremony in June.

##### 3.2. Modalities for the processing operation

<b>4. Lawfulness and purpose of the processing</b>
<b>4.1. Legal basis</b>
The processing operation is necessary for the performance and the support of the numerous tasks carried out by the EEA as mandated by Regulation (EC) No 401/2009 of 23 April 2009 on the EEA and on the Eionet.
<b>4.2. Grounds for lawfulness</b>
The data processing is considered lawful because it is necessary for the performance of tasks carried out in the public interest on the basis of Regulation (EC) 401/2009 (Article 5(a) of Regulation (EC) No 45/2001). Through submission of an application, the data subject unambiguously gives his/her consent to the processing operation (Article 5(d) of Regulation (EC) No 45/2001). There is no restriction under Article 20 of Regulation (EC) No 45/2001 and the data and processing operation do not require prior checking pursuant to Article 27 of that Regulation.
