Information and formalities necessary for evaluating if requirements are met: Exclusion criteria — to be eligible for participation in this contract award procedure, tenderers must not be in any of the exclusion situations referred to in Articles 93 and 94 of Council Regulation (EC, Euratom) No 1605/2002 of 25.6.2002, OJ L 248 of 16.9.2002 as last modified by (EC, Euratom) No 1995/2006 of 13.12.2006, OJ L 390/1 of 30.12.2006. To that effect tenderers are required to submit a declaration of honour (see Annex 1 to the tender specifications) in accordance with Article 134 of Commission Regulation (EC, Euratom) No 2342/2002 of 23.12.2002, OJ L 357/1 as last modified by (EC, Euratom) No 478/2007 of 23.4.2007, OJ L 111/13. Under the same provision, the tenderer to whom the contract is to be awarded will be required to produce evidence confirming the prior declaration unless this obligation is waived by the contracting authority.

Legal capacity — tenderers are requested to prove that they are authorised to perform the contract under national law, as evidenced by inclusion in a trade or professional register, or a sworn declaration or certificate, membership of a specific organisation, express authorisation, or entry in the VAT register. Tenderers shall provide an identification sheet (Annex 2 to the tender specifications) duly filled out and signed, a copy of inscription in a trade register, where applicable, and a copy of inscription in VAT registers.

- (a) appropriate statements from banks or evidence of professional risk indemnity insurance;
- (b) the presentation of balance sheets or extracts from balance sheets for at least the last 2 years for which accounts have been closed, where publication of the balance sheet is required under the company law of the country in which the economic operator is established;
- (c) a statement of overall turnover and turnover concerning the works, supplies or services covered by the contract during a period which may be no more than the last 3 financial years.

If, for some exceptional reason, which the contracting authority considers justified, tenderers or candidates are unable to provide the references requested by the contracting authority, they may prove their economic and financial capacity by any other means which the contracting authority considers appropriate.

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links, which it has with them. It must in that case prove to the contracting authority that it will have at its disposal the resources necessary for performance of the contract, for example by producing an undertaking on the part of those entities to place those resources at its disposal.

- d) external costs of transport and transport economy including the use of economic instruments and subsidies;
- e) impact of different types of fuel used in the transport sector including life-cycle impacts of different alternative fuels strategies;
- f) urban transport including the links between spatial development and transport demand, use of non-motorised transport and public transport in urban areas;
- g) impact assessment methodologies (CBA, EIA, SEA) in transport planning and assessment;
- h) experience in working with geographically-oriented transport datasets in GIS systems;
- i) experience with the use of scenarios and projections in transport analysis, facilitation of explorative workshops, etc.; and
- j) development and maintenance of indicator sets,

— junior consultants (JC): at least 3 CVs documenting a minimum of 6 years experience each as a junior consultant or analyst in at least 1 of the 10 abovementioned fields including advanced writing skills in English.

lot 2 — energy and environment:

— senior consultants (SC): at least 3 CVs documenting a minimum of 10 years experience each as a senior consultant or analyst in at least 1 of the 6 following fields including advanced writing skills in English:

- a) energy and environment policies, evaluation of the effectiveness of related policy measures and instruments covering all energy-related activities;
- b) energy systems (including renewable energy and energy efficiency, carbon capture and storage, nuclear technologies, grids) and their costs;
- c) environmental pressures and impacts caused by the energy sector as well as integrated assessment of such pressures;
- d) energy pricing, taxation, external costs of energy, use of economic instruments and subsidies;
- e) development of energy and environment indicators as well as energy balance methodologies; and

- f) development of energy outlooks/scenarios,
— junior consultants (JC): at least 3 CVs documenting a minimum of 6 years experience each as a junior consultant or analyst in at least 1 of the 6 abovementioned fields including advanced writing skills in English,
— CVs shall include detailed descriptions of key projects documenting actual tasks and responsibilities. The mere mention of titles or web-links will not be sufficient and can lead to rejection;
2. a list of the principal similar services provided (per lot and fields specified) in the past 3 years, with the sums, dates and recipients, public or private;
 3. a statement of the average annual manpower, the number of managerial staff and the numbers of senior consultants, junior consultants and assistants (all 3 per lot concerned) of the service provider in the last 3 years;
 4. a description of the measures employed to ensure the quality of services (procedures), and a description of the company's management procedures which ensures smooth running of specific activities;
