CHECKLIST OF DOCUMENTS TO BE SUBMITTED IN THE E-SUBMISSION APPLICATION

The purpose of the table below is to facilitate the preparation of the tender by providing an overview of the documents that shall be included in the e-Submission application (marked by ■), depending on the role of each economic operator in the tender (single/main contractor, subcontractor, for joint offers submitted by a consortium: coordinator/group leader, partner). Some of the documents are only relevant in cases of joint tenders submitted by a consortium, or when subcontractors are involved. Additional documents might be necessary depending on the specific characteristics of each tender.
