Information and formalities necessary for evaluating if requirements are met: Exclusion criteria — to be eligible for participation in this contract award procedure, tenderers must not be in any of the exclusion situations referred to in Articles 93 and 94 of Council Regulation (EC, Euratom) No 1605/2002 of 25.6.2002, OJ L 248 of 16.9.2002 as last modified by (EC, Euratom) No 1995/2006 of 13.12.2006, OJ L 390/1 of 30.12.2006.

To that effect tenderers are required to submit a declaration of honour (see Annex 1 to the tender specifications) in accordance with Article 134 of Commission Regulation (EC, Euratom) No 2342/2002 of 23.12.2002, OJ L

357/1 as last modified by (EC, Euratom) No 478/2007 of 23.4.2007, OJ L 111/13. Under the same provision, the tenderer to whom the contract is to be awarded will be required to produce evidence confirming the prior declaration unless this obligation is waived by the contracting authority.

Legal capacity — tenderers are requested to prove that they are authorised to perform the contract under national law, as evidenced by inclusion in a trade or professional register, or a sworn declaration or certificate, membership of a specific organisation, express authorisation, or entry in the VAT register.

Tenderers shall provide an identification sheet (Annex 2 to the tender specifications) duly filled out and signed, a copy of inscription in a trade register, where applicable, and a copy of inscription in VAT registers.

III.2.2) Economic and financial capacity:

Information and formalities necessary for evaluating if requirements are met: Proof of economic and financial capacity shall be furnished by 1 or more of the following documents:

- a) appropriate statements from banks or evidence of professional risk indemnity insurance;
- b) the presentation of balance sheets or extracts from balance sheets for at least the last 2 years for which accounts have been closed, where publication of the balance sheet is required under the company law of the country in which the economic operator is established;
- c) a statement of overall turnover and turnover concerning the works, supplies or services covered by the contract during a period which may be no more than the last 3 financial years.

If, for some exceptional reason which the contracting authority considers justified, the tenderers or candidates are unable to provide the references requested by the contracting authority, they may prove their economic and financial capacity by any other means that the contracting authority considers appropriate.

Economic operators may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links that they have with them. They must, in that case, prove to the contracting authority that they will have at their disposal the resources necessary for performance of the contract, for example by producing an undertaking on the part of those entities to place those resources at their disposal.

- d. proof that medical staff are allowed to practice medicine in Denmark (at the deadline for submitting tenders), are practicing (at the deadline for submitting tenders) medicine in Denmark and have been practicing medicine for at least 10 years,

— a reference list of similar services which the tenderer has provided in the past 3 years, documenting the dates, institutions (public or private) and contract volume;

— a detailed description of the tenderer's practice and the facilities and technical equipment available to the tenderer to provide the required range of services (based on the submitted documentation, visits to the tenderers' practices may be carried out);

— proof of mandatory language skills (EN); and

— an indication of the proportion of the contract which the service provider may intend to subcontract.
